SAFETY RULES

1. NO LIVE AMMUNITION IS ALLOWED ON ANY MEMBER INVOLVED IN SKIT OR DEMONSTRATIONS AT ANY TIME WHILE WEARING OR CARRYING A FIREARM.
2. FIREARMS WILL REMAIN IN HOLSTERS OR UNDER PHYSICAL CONTROL, SECURE AT ALL TIMES. IN CASES OR HOLSTERS WHEN NOT IN USE DURING A SKIT.
3. NO MEMBER WILL ALLOW ANY SPECTATOR OF ANY AGE TO HANDLE THEIR FIREARMS FOR ANY REASON.
4. NO FIREARM OF ANY KIND WILL BE POINTED TOWARDS ANYONE AT ANY TIME EXCEPT DURING A PERFORMANCE.
5. SHOULD ANY AUDIENCE MEMBER RUN INTO THE SKIT, DO NOT FIRE UNTIL THEY ARE REMOVED. If this occurs shout out, "Safety".
6. MINIMUM DISTANCE FOR SHOTS IS: 15 FEET FOR PISTOLS & 25 FEET FOR SHOTGUNS.
7. NEVER FIRE DIRECTLY TOWARDS ANOTHER REENACTOR OR AT THE SPECTATOR AREA.
8. NEVER FIRE A WEAPON THAT HAS BEEN DROPPED WITHOUT CHECKING IT FOR OBSTRUCTIONS.
9. NO HEAD SHOTS, NO STOMACH SHOTS, NO POINT BLANK SHOTS.
10. GUNS ARE NOT TO BE LOADED WITH BLANKS UNTIL IMMEDIATELY PRIOR TO A PERFORMANCE.
11. WEAPONS OF CHOICE SHOULD BE PERIOD CORRECT FOR THE TIME PERIODS 1849-1907 (PLEASE CHECK WITH THE PRESIDENT TO VERIFY WHAT AMMUNITION IS CURRENTLY AVAILABLE).
12. AT EVERY 2018 EVENT **Bob Redo** IS THE SAFETY OFFICER OF THE DAY AND RESPONSIBLE FOR CHECKING ALL WEAPONS PRIOR TO EACH PERFORMANCE. If Bob is not at said event ask who has been appointed as the Safety Officer of the day.
13. ALL FIREARMS MUST BE VERIFIED AS EMPTY AT THE CONCLUSION OF EACH PERFORMANCE BY THE SAFETY OFFICER – **BOB REDO (FOR 2018)**
14. ALL AMMUNITION WILL BE UNDER PHYSICAL CONTROL AND SECURED AT ALL TIMES.
15. PRIMERS MUST BE REMOVED OR DRILLED OUT IN ALL DUMMY ROUNDS CONTAINING BULLETS WHEN WORN IN CARTRIDGE BELTS.
16. IMPROMPTU PERFORMANCES OR SPONTANEOUS QUICK DRAW CONTEST ARE FORBIDDEN.
17. MEMBERS MUST ALWAYS FIRE AT LEAST TWO (2) FEET FROM THE FEET TO MAKE THEM TAP DANCE.

18. SAFETY DEMONSTRATIONS ARE AS FOLLOWS: THREE PEOPLE

- a. TALKER – LET HIM DO ALL THE TALKING
- b. SHOOTER - AIM FOR CLEAR AREA
- c. CAN PERSON – PLACE, RETRIEVE AND HANDLE CAN BEING CAUTIOUS OF SHARP EDGES, WALK AROUND AND DISPLAY DAMAGED CAN.

19. **ABSOLUTELY NO CONSUMPTION OF ALCOHOL OR UNLAWFUL SUBSTANCES WHILE WEARING FIREARMS OR PRIOR TO A PERFORMANCE THAT INVOLVES FIREARMS.**
